

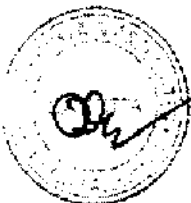

1. 

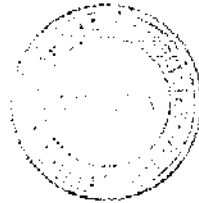
